Stakeholders Interactive Sessions (Day 1)

Participants will break out into their respective stakeholder groups for Day 1. This will provide a platform for shared understanding of the P&C 2013 and serve as an opportunity for learning from others in small self-selected groups. Participants will also be able to use these sessions to seek clarity on the changes in the P&C 2013. The interactive sessions will be led by a team of experienced facilitators supported by Secretariat staff and other Resource Persons familiar with the P&C 2013. The designated facilitators will guide the discussion with pre-set leading questions.

Participation the Stakeholder Interactive Sessions is open to all RT11 participants. Affiliate members and non- members who do not fall into any particular stakeholder group, can select a stakeholder group who has the most relevance to their interests for the purpose of the discussion.

Participants will experience:

- Buzz groups
- Panel discussion
- Reflection
- Creative expression

Questions and Reflections on Alignment of Aspirations with the P&C from each stakeholder group will be annotated, printed and put up on the “Breaking News” wall at the end of each day.

Open Space Technology (Day 2)

Open Space Technology (OST) is a “meeting technology” which draws on the principles of self-organization, inclusiveness, passion and responsibility, working together with respect. It encourages action rather than endless discussion, and leadership rather than blame. Passion engages people in the room. Responsibility ensures that implementation for moving toward a preferred future happens.

How does OST work?

Open Space runs on four Principles and one Law.

The four principles:

- Whenever you want to start is the right time to start
- Whoever comes is the right people to come
- Whatever happen during the discussion is the only thing that could have happened
- Whenever its over is over.

The one law:

“The Law of 2 Feet”

The facilitators will brief you on these principles and law early on the day.

All participants need to focus their attention to the RT11 theme, **“Our Support to P&C 2013 for A Sustainable Future.”**The theme provides the framework for the event. Participants are

invited to identify any topic (issue, challenge, question, insight, action) **within the theme** that day. Topics are written on a piece of paper by the hosts, announced to the group and posted on the “Market Place” wall for a particular time. The agenda will be created around a circle, driven by what people want to talk about, and the time needed for ideas to be shared and discussed will be set.

Participants are allowed to move around to any discussion groups according to their interests and join the discussions. So, whenever you find yourself neither learning nor contributing, it is your responsibility to move into another group or conversation where you can contribute.

Participants can decide which groups that they want to join. There will be three 90 minute-periods for concurrent discussions. The initiator or host of each group has only 2 responsibilities: to ensure that each person has the opportunity to speak and be understood, and to have someone take notes that can be posted on the “Breaking News” wall and shared with everyone.

From this point on the group is self-organizing. So, Be Prepared To Be Surprised!

Implementation Planning (Day 3)

From the previous sessions of Day 1 and 2, participants are expected to set Implementation Plan early on Day 3. The Implementation Plan can be by stakeholder groups or, by cross-stakeholders cooperation. The format of the Implementation Plan should cover:

1. The participants, the institutions, and the stakeholder groups
2. The Aspiration; could be in the form of goal or vision
3. The Expected Impact of having this goal or vision
4. The Roadmap; activities of each milestone.

It is expected that the Implementation Plans will encourage the implementation and support of P&C as the objective of RT-11. The Implementation Plan will be shared to the entire assembly before the General Assembly.
